An application for a driving licence shall be accompanied by;-

- (a) One passport size photograph
- (b) A certificate from the Commissioner of Police that the applicant is capable of driving and fully controlling the vehicle in respect of which the application is made or a valid foreign driving permit.
- (c) Where a medical test is required a medical certificate from the Director of Health Services or medical practitioner approved by him about the applicant's physical fitness to drive the vehicle.
- (d) In case of an application for an International driving permit the current applicant should Produce his/her, (1) One passport size photograph (2) Licence and processing fee RS.550/-

---

The following fees must be sent with the application:-

- (a) Processing an application Rs.50/-
- (b) Licence Fee RS.200/- for 12 months, Rs.500/- for 60months

NB: A surcharge of 10% of the licence fee will be added for each month or part thereof which has elapsed from the date of expiration of the lodging of an application.
